in connection with the provision of our newsletter and in connection with our marketing activities, including contests, advertising, discounts and similar promotions (hereinafter referred to as "Services"), as well as certain other cases of processing of your personal data that may occur during your visit to Fly Vista, Levels Prague and Back in Time located at the premises of Máj Národní at Národní 63/26, Postal Code: 110 00, Prague 1 - Nové Město (hereinafter collectively referred to as "Our premises").

Please note that depending on the nature of the Services you use, special personal data processing policies may apply to you and will be duly communicated to you where applicable.

### 1. IDENTIFICATION OF THE DATA CONTROLLER

#### 1.1. Personal data controller

The controller of your personal data is **Infinite X Prague s.r.o.** ("Data Controller" or "we").

## 1.2. Role of the data controller

The Data controller has entered into several data processing and service contracts with service providers, which technically enables you to use our website.

## 1.3. Purpose of processing personal data

The Data controller processes your personal data according to your choice for the following purposes:

- a. subscribing to the newsletter in order to receive the newsletter;
- b. marketing activities, including analysis of your use of services at Our premises, as set out in more detail in Article 5 of this Policy, and to provide you with relevant offers and competitions;
- advertising and sending communications about events held at Our premises, sending discount vouchers to Our premises, making bookings for our services and communicating about bookings;
- d. improving its services;
- e. taking care of you as a customer.

#### 2. METHODS OF COLLECTING PERSONAL DATA

### 2.1. We collect your personal data in the following ways:

- a. directly from you, or
- b. based on your use of the Services when using the website and your consent to the use of cookies, we collect the cookies you receive as detailed in the cookies tab.

For details on the processing of your personal data, please refer to the table set out in Article 5 of this Policy.

#### 3. SHARING OF PERSONAL DATA

### 3.1. Sharing of personal data

We may share your personal information with:

- a. our processors who act according to our instructions;
- b. relevant authorities or legal entities to fulfil legal or regulatory requirements;
- c. acquirers in the event of a sale or transfer of our assets or a portion thereof;
- d. with our insurers, lawyers, auditors, tax advisors, and other consultants;
- e. courts for enforcing claims and protecting our legal position; and
- f. partners who provide services on our websites, with these services subject to the partners' terms of use and privacy policies.

#### 4. DATA PROTECTION

### 4.1. Data security

The security of all personal data we process is our priority. For this reason, we have put in place appropriate technical and organisational measures and carefully select our service providers, consultants and business partners.

#### 4.2. Personal data processing contracts with our providers

We have entered into data processing agreements with each of our service providers to the extent required by applicable law and have verified their technical and organisational measures. These companies are only authorised to process your personal data in accordance with our instructions.

#### 6. YOUR RIGHTS IN RELATION TO YOUR PERSONAL DATA

### 6.1. Your rights

Under applicable law, you have different rights in relation to the processing of your personal data depending on the specific situation:

## a. Right of access to your personal data

You have the right to request verification of whether we are processing your personal data and, if so, to obtain a copy of that data.

### b. Right to rectification of your personal data

If your personal data we process is inaccurate, you have the right to request its correction.

# c. Right to erasure of your personal data

You may request the deletion of some or all of your personal data.

## d. Right to object to the processing of your personal data

You have the right to object to the processing of your personal data. This means that you have the right to request that we stop processing your personal data until we can demonstrate that there are compelling reasons for processing it which override your interests, rights and freedoms or where necessary for the establishment, exercise or defence of legal claims. If we object to the processing of personal data for direct marketing purposes, we will immediately stop processing your personal data for these purposes.

### e. The right to limit the processing of your personal data

You have the right to request the restriction of the processing of your personal data, in particular in cases where you doubt the accuracy, lawfulness or necessity of the processing. In such situations, we will only process your personal data for the establishment, exercise or defence of legal claims, or for the protection of another natural or legal person, or in accordance with another limited reason set out in applicable law.

### f. Right to data portability

You have the right to request a copy of the personal data you have provided, including in a format that is interoperable, or, if appropriate and technically feasible, you may request that it be transferred directly to another data controller.

## 6.2. Withdrawal of consent

If consent is the legal basis for the processing of your personal data, you may withdraw this consent at any time without giving any reason. Withdrawal of consent does not affect the lawfulness of the processing that took place before the withdrawal.

## 6.3. Unsubscribe from marketing communications

If you do not wish to receive marketing communications, you can request to stop receiving them:

- a. by sending an email to the contact details provided; or
- b. directly by changing your user account settings, if any; or
- c. by clicking on the unsubscribe link in our communications.

### 6.5. Submission of an application

To exercise your rights effectively, it is important to state in your application:

- a. what personal data is involved; and
- b. which rights you want to exercise.

In order to comply with the protection of third party rights, verification of your identity may be required, including the provision of identifying information such as loyalty card number or date of birth and, if necessary, proof of identity.

We will respond to your request within 1 month of receiving it. If necessary, we may extend the deadline by 2 months depending on the difficulty of processing the request and the current number of requests. We will inform you of any extension within 1 month of receiving your request at our address.

### 6.6. Filing a complaint

If you believe that the processing of your personal data violates applicable data protection laws, you have the right to lodge a complaint with the competent data protection authority in the country of your habitual residence, place of work or place of alleged violation. ### 7. CHANGES AND UPDATES TO THIS PERSONAL DATA PROCESSING POLICY

In the event that such a change is required by applicable law to be notified to you or to obtain your consent to any new processing set out in the updated version of this policy, you will be notified or asked to consent to the new use of your personal data.
